1 Introduction

- 1.1 This document accompanies the applications made by SEGRO Properties Limited (DCO Applicant) and SEGRO (EMG) Limited (MCO Applicant) (together 'SEGRO' or 'the Applicants') relating to a second phase at East Midlands Gateway Logistics Park (EMG1).
- 1.2 EMG1 is a nationally significant infrastructure development comprising a rail freight terminal and warehousing. It was authorised by The East Midlands Gateway Rail Freight Interchange and Highway Order 2016 (SI 2016/17) (the EMG1 DCO) and is substantially complete.
- 1.3 This second phase is referred to as 'East Midlands Gateway 2' or 'EMG2' or the 'EMG2' Project' or the 'Proposed Development' and comprises the following main components:

- 1.6 The first is made by the DCO Applicant for a Development Consent Order for the EMG2 Works and the Highway Works (referred to as the DCO Application and the DCO Scheme).
- 1.7 The second application is made by the MCO Applicant for a material change to the existing EMG1 DCO for the EMG1 Works (referred to as the MCO Application and the MCO Scheme).



Tip cameras could target cross-border dumping

NUMBER plate recognition cameras could be introduced at Nottinghamshire's new tips as part of efforts to save the county over £400,000 a year. Two new tips are set to be built to replace sites

Two new tips are set to be built to replace sites closing in West Bridgford, Kirkby and Mansfield – and Nottinghamshire County Council is now considering how it could

introduce Automatic Number Plate Recognition (ANPR) cameras at the sites.

The Conservative-run authority has previously said that Nottinghamshire's tips are "at risk of abuse" from people in neighbouring areas who are dumping their rubbish in the county to avoid strict rules at their own centres.

A review carried out for the council estimates that cross-border dumping from places like Lincolnshire and Rotherham could

be costing the authority over £408,000 a year.

In a new report, the council says: "The primary benefit of ANPR to local authorities is its ability to prevent misuse by non-residents and commercial traders.

"It can also support with monitoring and enforcement of access restrictions and track the usage of those who do use the sites.

MORE than 100 Derby call centre jobs have been put at risk by plans for a major UK company to move its customer services to India.

Firstsource employs "around 130" staff in Riverside Road, Pride Park. Most were hurried into a company meeting and told their jobs were at risk. They were informed Sky, one of its biggest clients, had announced plans to "make changes" to its customer service and they could soon be made redundant as a result.

One staff member said: "It has left a load of people worried sick. I locked myself away all weekend crying."
